EU BUDGET SUPPORT FOR RULE OF LAW



The EU's support to the justice sector in Armenia has since 2009 primarily been provided as Budget Support. These programmes have consisted of financial transfers to the Armenian treasury combined with complementary technical assistance.

THE 3 BUDGET SUPPORT PROGRAMMES

1. SUPPORT TO JUSTICE SECTOR REFORMS IN ARMENIA

Period of implementation: 2024-2026 PHASE II

Budget: **€11.000.000**

OBJECTIVE:

The overall objective is to contribute to the achievement of international standards in the areas of justice and anti-corruption related to integrity and accountability, independence, quality, efficiency and access to institutions to provide adequate services to the population, including vulnerable groups.

KEY ACHIEVEMENTS:

- Development and adaptation of legislative amendments
- Increased visibility, credibility and reliability of the Arbitration and Mediation Centre
- Reduction in the percentage of non-suspension cases in criminal cases

3. JUSTICE REFORM MONITORING IN ARMENIA JUREMONIAPeriod of implementation: 2024 - 2026

KEY GOAL:

The aim is to achieve that CSOs are empowered to meaningfully engage in the Justice sector reforms in Armenia.

KEY ACHIEVEMENTS TO DATE:

- Subgrants to Civil Society Organizations focusing on access to Justice.
- Two grants for Forcibly Displaced People from Nagorno Karabakh, specifically addressing their needs for access to Justice and rehabilitation

- Digitalization of asylum procedures and enhancement of the national reception capacity for asylum-seekers.
